



Thank you for contributing to the TEDx event identified below (the "Event"). To proceed as a confirmed Speaker, you must complete and sign this release ("Release") before the TEDx Event and fax/email it to your TEDx contact. The Event is operated under a license issued by TED Conferences LLC, located at 330 Hudson Street, 11th Floor, New York, NY 10013 ("TED"), which may authorize its partners and licensees to distribute the talk worldwide at its sole discretion. **For consideration of the opportunity to participate in the Event as a TEDx Speaker, sign below if you agree to the terms of this Release.** Annotations are provided for description purposes only.

Section 1. License.

You grant TED and the Event organizers a license to record your talk and to TED to exclusively distribute your TEDx Talk worldwide. You grant the Event organizers and authorized entities ("TEDx Team") the right to record, stream, film, and photograph your TEDx Talk at the Event and grant TED the exclusive, unrestricted, worldwide, perpetual right to display, distribute, perform, reproduce, edit, create derivative works (including multilingual translations using AI) from, and/or otherwise use the TEDx Talk, in whole or in part, with or without video, in any media without any further approval from you. This includes the ability to translate into any language, sub-license, and exclusively distribute your TEDx Talk anywhere around the world, including promotion, advertising, or marketing of the TEDx Talk or associated information as applicable. Except as required by law, you may not revoke the rights granted in this Release. In addition, providing a TEDx Talk is fully voluntary, and you won't receive any payment for presenting a TEDx Talk and/or Supporting Information.

Section 2. Copyright and Originality.

Your TEDx Talk must be original, accurate, and adhere to our guidelines. If you include any slides, you must respect intellectual property rights and have permission to publish them. You will review the Clearance Guidelines (page 2 of this document) in detail and agree only to use third-party content provided with consent and license rights for TED to publish perpetually across all media platforms as embedded within your TEDx Talk. You have not copied, taken, or infringed any third-party content in developing your talk, including slides that may accompany your TEDx talk; otherwise, it may be taken down.

Section 3. Publication discretion and Privacy Consent.

TED has no obligation to publish your TEDx Talk. If we do, we require your full consent, which is described below. The TEDx Team and/or TED aren't obligated to use, publish, or distribute your TEDx Talk or Supporting Information (as defined below) in any way. You fully consent and agree to have your personally identifiable information (e.g., photograph, likeness, biographical data) (collectively, "Supporting Information") published and distributed worldwide by TED and the TEDx Team. If your TEDx Talk is selected to build multilingual translations using AI technology, you authorize TED to modify, dub, or otherwise adapt your voice, likeness and personal characteristics embedded in the audio and visual elements of the TEDx Talk using AI to create versions accessible in multiple languages. If you wish your talk to be removed from TED's platform at any time post-publishing, TEDx will honor that request and remove your talk from TED's page and will update other distribution channels as applicable.

Section 4. Conditions for sharing your TEDx Talk.

If you misuse the brand, we may be required to take down your TEDx Talk or take other legal action if applicable.

- **TEDx Reference (Permissible)**
 - If your TEDx Talk is published, you will have the right to re-post or embed the TEDx Talk solely by using TED's links or feed to enable as many views as possible for non-commercial purposes.
 - When referencing your talk or yourself as a speaker, always indicate the specific event and year you spoke (e.g., TEDxAnytown 2024).
 - When sharing your TEDx Talk, only do so in a **non-commercial manner**, which means you cannot promote a business or your TEDx experience for a fee, such as TEDx speaker coaching.
- **TEDx Violations (Your Talk Will Be Removed)**
 - You misuse the Event name or the TED name, logo, trademarks, or service marks (the "TED Marks") for any commercial purpose, e.g., sale of books, podcasts, videos, or other media.
 - You publish the TEDx talk without using TED's links or embeds.
 - You misuse the TED Marks to sponsor, endorse or suggest an affiliation with any third party or business.
 - You misuse the TED Marks in connection with any work or service purporting to offer guidance on giving an effective TED Talk or TEDx Talk or how to get chosen to deliver a TED Talk or TEDx Talk.

Section 5. Responsibility for TEDx Talk and Waiver.

You are responsible for any legal claims that arise from your TEDx Talk and agree to release any claims against TED from your presentation or actions. In addition, this Release is enforceable, binding, and governed by NY law in the US.

If any third-party claims arise stating your actions or the use of the TEDx Talk violates their rights, including infringement, defamation, or privacy, you agree to indemnify, hold harmless, and to cooperate fully with TEDx Event and TED to defend against or otherwise respond to such claim, pay license fees, if applicable, and provide written evidence of ownership of any portion of your TEDx Talk if required. You agree to waive any claims against TEDx Event and TED and its licensees arising out of the use of the TEDx Talk consistent with this Release. This Release may not be modified except in writing, signed by both parties. This Release is governed by New York law without regard to conflict-of-law principles. If you are under 18, a signature from your parent/guardian is required below.

TEDx SPEAKER RELEASE CLEARANCE GUIDELINES

VISUALS

If you decide to add slides or other visuals to the TEDx Talk, we need you to ensure that the materials, whether pictures, clips, images, animation, or drawings—are usable, editable, and licensed to TED to use in the same manner as any component of your TEDx Talk, and does not contain **third party content** that has not been authorized, paid for or licensed for our purposes.

THIRD-PARTY CONTENT

Third-party content refers to any content that is not treated 100% by you, for you, or owned by you but is instead owned by another person or entity, such as a corporation (logos), movie studio (clips), publishers (music or books), not for profits, or one or many writers (clips or lyrics of songs). **Third-party content is protected by copyright, and owners have exclusive rights to use and publish it as they see fit. Just because it is publicly displayed or downloaded from the Internet does not mean legal rights are provided to use it in your TEDx Talk.**

USING GENERATIVE AI TOOLS IN SLIDES

AI tools are computer programs that can create new content independently, usually responding to a "prompt" or input. This content can include text, images, music, and software code. Examples include ChatGPT, ChatGT Plus, Midjourney, Stable Diffusion, Dall- E, Bard, Bing Chat, and other similar tools. If you input your own original content, you may use AI Tools for your slides for illustration, design, or impact. **Please do not use AI tools with copyrighted material, data, or input that is not original to you. Otherwise, the content may be infringing and based on another party's intellectual property without permission.**

DON'T ASSUME ONLINE CONTENT IS FREE

Often, speakers make the mistake of assuming Internet content is free and permitted due to "fair use" or is considered "public domain." Much of what is available online is shared for "viewing" under very specific terms and conditions. This includes platforms and sites such as TikTok, Facebook, LinkedIn, X, Google Images, and even some images compiled by libraries, Wikipedia, or others. **When selecting or downloading images, memes, or clips found online, please remember to get permission from the owner or original publisher of the content.**

RECORD KEEPING FOR LICENSES

When you license any type of content, please keep a record of your license rights, consents, or permissions in case verification is ever needed by TED to provide evidence of ownership and rights. **If a copyright owner requests proof of ownership, you need to have the digital copy or hard copy of the release and/or consent available for evidence in case of a copyright strike or if the TED teams receive a cease and desist.**

PHOTOGRAPHS

We encourage you to take your own photos or drawings to illustrate your TEDx Talk. This will enhance the presentation with a personal touch and avoid asking other copyright owners for permission. Even using Creative Commons images, stock websites, and/or image libraries can be tricky because it may not allow the flexibility we need to publish it with your slides.

As a reminder, always acquire "perpetual, worldwide, commercial distribution" in the licenses available and include a photo credit from your source if required.

CLIPS OF FILMS, MUSIC, OR ANIMATIONS

Simply put, it is better NOT to use a clip that is popular culture or from TV or a film and is published content that a third party owns. You may only use clips if you have already secured **full rights** to use them for your TEDx Talk. In this case, before giving the talk, you need to obtain explicit permission from the copyright owner, whether a person or an organization.

As a note of caution, the more popular the clip, the more expensive or complex the release may be due to the number of requests and demand for use (e.g., \$5000 per clip as a license fee to publish 20 seconds in a TEDx Talk)

PERFORMANCES

If you plan to perform on stage, please use an original work you own 100% in publishing, the recording (if applicable), etc. If not, you will have to secure the usage rights for each song from the writers, the publisher (e.g., Sony/ ATV, Warner Chappell), the composer, and/or the record company, and other groups who may have to approve rights when recorded from the TEDx Stage.

Acquiring performance licenses requires coordinating multiple permissions and is an area that is highly regulated for compliance, so obtaining permission is complex and can be expensive. This takes time and money, so it is best to use your original work that you wholly own.
